



BSC AI Factory – Incubation Space

Resolution of the 1.2 Call for Incubation
Space of the BSC AI Factory:

In accordance with the timeline established for the 1.2 Call of the BSC AI Factory Incubation Space (application deadline: 19 November 2025; lottery: 20 November 2025; acceptance process until 26 November 2025; implementation period from 1 December 2025 to 31 March 2026), the selection procedure has been duly carried out in line with the Rules for Participation.

The procedure consisted of two stages:

- Eligibility Screening:** All submitted applications were assessed to verify compliance with the eligibility and selection criteria defined in the Call. Only those applicants fulfilling the requirements were admitted to the subsequent stage. Two of the proposals submitted could not be accepted because they did not comply with some aspect of the rules for participation.
- Random Allocation:** Among the eligible applications, a transparent random draw was conducted [[VIDEO LINK](#)] ensuring impartiality and equal opportunities for all candidates.

Upon completion of the above procedure, it is hereby resolved that **10 companies** are awarded beneficiary status under the 1.2 Call of the BSC AI Factory Incubation Spaces.
