PREAMBLE AND LEGAL BASIS

The present document establishes the official Regulatory Framework and Rules of Participation (hereinafter, the “Rules”) governing the application, selection and commitment process for the **BSC AI Factory Incubation Space Programme** (hereinafter, the “Incubation Programme”).

The Incubation Programme is a strategic service offered by the **BSC AI Factory**, an initiative that aims to accelerate the adoption, experimentation, and scaling of advanced AI technologies across Europe.

The **BSC AI Factory** itself is a European **consortium led by the Barcelona Supercomputing Center (BSC-CNS)**. It brings together key national research and innovation actors, including:

- **Fundação para a Ciência e a Tecnologia (FCT)** – Portugal
- **The Scientific and Technological Research Council of Turkey (TÜBİTAK)** – Turkey
- **Institutul Național de Cercetare-Dezvoltare în Informatică (ICI Bucharest)** – Romania

The Incubation Programme aims to support high-potential, early-stage AI startups, SME’s, Public Bodies, AI entities or innovation stakeholders by providing access to a high-performance computing environment, expertise, and infrastructure. This mission is designed to catalyze entrepreneurial activity, foster collaboration, and position the BSC AI Factory as a reference node in Europe for applied artificial intelligence. These Rules are designed to ensure a selection process that is transparent, non-discriminatory, and consistent with the BSC AI Factory mission.

SECTION I. DEFINITIONS AND SCOPE

Article 1. Definitions

- The Incubation Programme:** BSC AI Factory Incubation Space Programme
- The Organizer:** The BSC AI Factory Consortium, led by Barcelona Supercomputing Center (BSC-CNS), and including Fundação para a Ciência e a Tecnologia (FCT), The Scientific and Technological Research Council of Turkey (TÜBİTAK) and Institutul Național de Cercetare-Dezvoltare în Informatică (ICI Bucharest).
- Applicant:** Any startup, entrepreneur or stakeholder related to AI seeking admission to the Incubation Programme.
- Participant/Beneficiary:** An Applicant formally selected and admitted to the Incubation Programme.
- Batch:** A group of beneficiaries participating concurrently in the Programme.
- Hot desk:** The shared workspace area available for reservation by Participants.
- Occupancy Rate:** The percentage of effective use of the Incubation Space by a Participant during the Incubation Programme, calculated based on verified presence data, including but not limited to hot desk reservations, access control records, and/or other monitoring tools designated by The Organizer.
- Space Manager:** Ultimate responsible for the day-to-day management of the offered Incubation Spaces, including incidence resolution and providing support to Participants.

- i. **Incubation Site:** The physical incubation location assigned to a selected Participant within the Incubation Programme. Each Incubation Site shall operate independently in terms of activities, onboarding process, occupancy monitoring, and space management.

For Call 3, the following Incubation Sites are available:

- Barcelona (Spain) – up to 17 (or up to 20, subject to Article 6.1) Participants
- Porto (Portugal) – up to 5 Participants
- Lisbon (Portugal) – up to 5 Participants
- Bucharest (Romania) – up to 2 Participants

Each Incubation Site shall constitute an independent operational Batch under the same Call.

Article 2. Scope

These Rules govern all phases of Call 3 across all available Incubation Sites, including application, eligibility verification, selection process, and the rights and obligations of the selected Participants for the duration of the Batch (October 5th, 2026, to March 31st, 2027).

Each Incubation Site shall operate independently with respect to onboarding activities, incubation services, space usage, and local programming.

SECTION II. MANDATORY ELEGIBLE CRITERIA

Article 3. Criteria for Applicants

To be considered for the Incubation Programme, applicants must satisfy the following mandatory requirements, which must be verifiable at the time of application:

Criteria	Requirement
1. Legal Status	The company must be legally incorporated and have its own tax identification number in the European Union.
2. Corporate Age	Between 0 and 10 years since legal incorporation , unless justified (e.g. pivot, new AI product line, recent scale-down).
3. AI Technology	Must demonstrate intensive use, development or investment in AI Technologies (e.g. trained models, annotated datasets, validated algorithms). <i>Projects should be at Medium and High Readiness Level determined in the User Journey from One-Stop Shop. (https://www.bsc-aifactory.eu/one-stop-shop/)</i>
4. Company Size	The company must have fewer than 20 employees .

5.Sector Priority	The Company should belong to one of the AI Factory's priority sectors: Health, Agriculture & Climate, Finance & Legal, Policy Making & Public Administration, Communication & Media, Energy.
6.In-person Availability	A minimum of 1 employee must be available to be in-person in the offices, at least 3 times per week.

Article 4. Discretionary Consideration

Applicants operating outside the defined strategic sectors may be considered, provided they demonstrate intensive use, development or investment of AI.

SECTION III. APPLICATION AND SELECTION PROCEDURE

Article 5. Application Process

For Call 3, Applicants shall skip the Initial Onboarding step and submit their application directly via the official online form. The required form [Incubation Programme Registration Form - Call 3](#).

Article 6. Selection Mechanism

6.1 Applications will be assessed and ranked independently once the call has closed, provided that they have submitted an Executive Summary (maximum 5 pages), Presentation Video (maximum 1min) and a Company Deck (Optional).

6.2. For Call 3, a maximum of thirty-six (36) Applicants will be selected across all Incubation Sites, distributed as follows:

- Barcelona: up to 17 Participants (3 places are reserved for winners of the previous Acceleration Programme edition, as established in the respective rules; if none of the 3 winners exercise their right, the number may be extended to up to 20 places, following the ranking order established by the evaluation panel)
- Porto: up to 5 Participants
- Lisbon: up to 5 Participants
- Bucharest: up to 2 Participants

Applications shall be evaluated and ranked independently for each Incubation Site.

6.3. Eligibility Verification

Upon closure of the application period, the Organizer shall verify that all submitted applications comply with all mandatory eligibility criteria set out in Article 3 of these Rules.

Only applications that fully meet such criteria shall be considered eligible applications and proceed to the selection stage.

6.4. Direct Admission in Case of Insufficient Applications

In the event that the total number of eligible applications for a given Incubation Site is equal to or lower than the number of available places allocated to that Site, all eligible Applicants for that Incubation Site shall be directly admitted to the Incubation Programme, without the need for an external evaluation process, provided that they meet the eligibility requirements.

6.4. Evaluation in Case of Competitive Selection

Where the number of eligible applications for a given Incubation Site exceeds the number of available places allocated to that Site, the eligible applications for that Incubation Site shall be subject to a competitive evaluation process carried out by a panel of BSC AI Factory staff members (hereinafter, the “Evaluation Panel”).

The Evaluation Panel shall act in accordance with objective and impartial criteria, and its decisions shall be final and binding.

6.5. Evaluation Criteria and Scoring System

Eligible applications shall be assessed based on the following evaluation criteria, with a maximum total score of 100 points:

Evaluation Criteria	Description	Maximum Score
1. Quality and maturity of the AI solution	Assesses the level of technological development of the AI solution, including its robustness, validation, and readiness for real-world application. Evaluation will consider: • Maturity of the AI models, algorithms, or systems developed. • Quality, availability, and management of data used. • Level of testing, validation, or deployment achieved. • Technical robustness, reliability, and performance of the solution.	30 points
2. Disruptiveness, Strategic Relevance and Use Case Fit	Evaluates how well the project’s use case addresses a clearly defined problem, the degree of disruptiveness or innovation introduced and the fit within the strategic context of the Incubation Programme. Evaluation will consider: • Clarity and relevance of the problem or need addressed. • Suitability of the AI-based solution for the proposed use case. • The degree of disruptiveness or innovation introduced by the solution. • Applicability of the solution to real-world scenarios.	25 points

3. Team capacity	Assesses the experience, skills, and execution capacity of the founding team, as well as their level of commitment to the Programme. Evaluation will consider: • Complementarity of technical, business, and operational profiles. • Relevant prior experience of the team members. • Ability of the team to execute the proposed project. • Availability and commitment during the incubation period.	20 points
4. Scalability and impact potential	Evaluates the potential of the project to grow and generate impact beyond the incubation phase. Evaluation will consider: • Scalability of the technology and solution. • Potential for market expansion or replication. • Expected economic, social, or technological impact. • Feasibility of long-term growth and sustainability.	15 points
5. Relevance and Added Value of the BSC AI Factory Environment	Assesses how well the project fits the BSC AI Factory environment, including which AI Factory services, computational infrastructure, HPC resources, and expert knowledge from BSC, are relevant for the development of its solution, and how the startup plans to leverage these during the Acceleration Programme. Evaluation will consider: • The added value the project brings to the AI Factory community. • The planned and realistic use of HPC/AI computational infrastructure provided through the programme. • The relevance of the AI Factory's services and resources for the project.	10 points
TOTAL		100 points

6.6. Ranking and Selection

Following completion of the evaluation conducted by the Evaluation Panel for each Incubation Site, a ranking of eligible applications for that Site shall be established, ordered from highest to lowest score.

The highest-ranked applications for each Incubation Site, up to the number of available places allocated to that Site, shall be provisionally selected for participation in the Incubation Programme.

6.7. Waiting List and Replacement Procedure

In all cases where the number of eligible applications for a given Incubation Site exceeds the number of available places allocated to that Site, an official ranked waiting list shall be established for that Incubation Site based on the final evaluation scores obtained during the selection process.

Applicants included in this Site-specific waiting list may be invited to join the Incubation Programme in the following circumstances:

- Withdrawal or non-acceptance by a provisionally selected Applicant;
- Failure to complete onboarding requirements within the established timeframe;
- Voluntary withdrawal during the Batch;
- Temporary suspension or definitive exclusion of a Participant in accordance with Section V and Annex 1.

Vacant positions shall be offered to the next highest-ranked Applicant on the waiting list corresponding to the relevant Incubation Site, following the established ranking order, until all available places for that Site have been filled.

The validity of each Site-specific waiting list shall extend throughout the entire duration of the Batch.

6.8 Site-specific Evaluation and Selection

Eligible applications shall be evaluated and ranked separately for each Incubation Site.

Selection decisions, waiting lists, and replacement procedures shall be managed independently at Site level, according to the number of available places in each location.

Participation in one Incubation Site does not grant access to facilities, services, or activities provided at other Incubation Sites.

Article 7. Resolution, acceptance & Appeal Procedure

7.1. The final resolution of the process will be posted on the official BSC AI Factory website and individual notifications being sent by email to the selected Applicants.

7.2. Selected Applicants will be granted five working days from the date of notification to formally accept or decline the offer. Failure to formally accept the offer within this 5-days period will be construed as a definitive rejection.

7.3. Applicants who disagree with the outcome of the selection process may submit a formal request for review (hereinafter, the “Appeal”) within five (5) working days from the date of notification of the selection results.

Appeals must:

- Be submitted in writing via email to the official contact address indicated in the Call.
- Clearly state the grounds for disagreement.
- Include any supporting documentation deemed relevant.

Upon receipt of the Appeal, the Organizer shall review the application process exclusively in relation to:

- Compliance with the eligibility criteria established in Article 3.
- Correct application of the evaluation procedure described in Article 6.

The Organizer shall issue a reasoned written response within a maximum period of ten (10) working days from the date of receipt of the Appeal.

The submission of an Appeal shall not suspend the execution of the Incubation Programme or the onboarding of provisionally selected Participants.

SECTION IV. PARTICIPANT RIGHTS AND MANDATORY COMMITMENTS

Article 8. Rights of the Participant (Value Proposition in Annex 2)

Selected Participants shall be granted access, for the duration of the Batch, exclusively to the facilities and resources available at their assigned Incubation Site.

It is expressly stated that all resources and facilities detailed below are common areas within the relevant Incubation Site and are to be shared among all Participants assigned to that Site, as well as other individuals and entities operating within the same premises, subject to the Code of Conduct (Annex I).

Facilities and services may vary depending on the Incubation Site and may include:

- a) Access to a Hot Desk area, with a maximum of five (5) desks per Applicant, subject to prior booking through the official management tool.
- b) Office facilities equipped with essential infrastructure (including desk and chair, printer, microwave, coffee machine, fridge and local office management support).
- c) Shared meeting rooms, subject to availability and prior booking through the official management tool.

Article 9.

9.1 Mandatory Commitments

Selected Participants acknowledge that the Incubation Spaces are a limited, shared public resource and commit to its efficient use and fulfilment of the following commitments:

- a. Active participation in the incubation space's activities, including technical workshops, networking events, and visibility initiatives.
- b. Mandatory attendance at the onboarding session of each incubation site.
- c. Mandatory membership in Tech Barcelona, which grants access to shared facilities, community benefits and networking platforms, only for the Barcelona Incubation Site.
- d. Repetitive failure to comply with the minimum on-site presence of three (3) days per week at the assigned Incubation Site, as established in the selection conditions, without duly justified cause, shall be considered a Moderate Breach (Tier 2) under the Disciplinary Policy set forth in Annex 1, and may give rise to the corresponding sanctions, including those affecting continued participation in the Programme.
- e. After being selected, each Participant must provide proof of valid civil liability insurance covering potential damages to persons, equipment, or facilities within the Incubation Site. In the absence of such insurance, the Participant shall assume full financial and legal responsibility for any damages caused during its participation in the Incubation Programme.

Article 9.2 Occupancy Requirement for Future Eligibility

- a) Only Participants that achieve an average Occupancy Rate of at least sixty percent (60%) over the duration of the batch shall be considered eligible to apply for future calls of BSC AI Factory incubation programs or monthly stays on the Coworking Programme.
- b) The Occupancy Rate shall be calculated by the Space Manager using objective data sources, including workspace booking systems, access records, and attendance monitoring tools.
- c) The Organizer reserves the right to consider duly justified exceptions (e.g. medical reasons, business travel, force majeure), provided they are formally communicated and documented.

SECTION V. CODE OF CONDUCT AND TERMINATION

Article 10. Code of Conduct

All Participants must strictly adhere to the Code of Conduct (Annex 1), which mandates the following principles:

- Strict prohibition on sharing sensitive or proprietary information of other companies without explicit consent.
- Prohibition of verbal/physical violence, intimidation, harassment, or discriminatory behaviour.
- No use or presence of alcohol or drugs during working hours or within the space.
- Encouragement of mutual support, knowledge sharing, and cooperation.
- Responsibility for maintaining clean, organized workspaces and shared areas.
- Use of facilities and equipment must be respectful and for their intended purpose, in full compliance with the general building regulations and common policies established by the building management.
- No tax domiciliation of the Participants in the Incubation Spaces.

Article 11. Termination and exclusion

The Organizer reserves the right to expel any Beneficiary that fails to comply with any of the regulations listed in the Code of Conduct. Failure to comply may lead to warnings, loss of privileges, or definitive exclusion from the Incubation Programme.

Persistent and unjustified underuse of the Incubation Space, despite prior written notice from the Organizer, may be considered a Moderate Breach under Annex 1, where such behavior negatively impacts the efficient allocation of shared resources.

In the event of termination, exclusion, or voluntary withdrawal of a Participant, the Organizer reserves the right to replace the vacant position by selecting the next eligible company from the official waiting list corresponding to the relevant Incubation Site.

SECTION VII. INTELLECTUAL PROPERTY AND JURISDICTION

Article 13. Intellectual Property

All Intellectual Property rights, including but not limited to patents, copyrights, and trade secrets, generated or developed by the Participants during their time in the Programme shall remain the exclusive and absolute property of the respective Participant company. The Organizer makes no claim to such property.

Article 14. Applicable law and Jurisdiction

These Rules of Participation shall be governed by and construed in accordance with the laws of Spain.

Any dispute, controversy or claim arising out of or in connection with these Rules, including their interpretation, application or validity, shall be submitted to the competent Courts and Tribunals corresponding to the place where the relevant Incubation Site providing the services to the Participant is located.

For the avoidance of doubt, disputes relating to the implementation of the Incubation Programme at a specific Incubation Site shall fall under the jurisdiction of the Courts and Tribunals of the country in which that Incubation Site is physically established.

ACCEPTANCE OF THE RULES FOR PARTICIPATION

All applicants must acknowledge and accept these Rules of Participation as a mandatory condition to take part in the selection process. A signed copy of this document must be uploaded together with the application materials through the official submission form at the time of application.

ANNEX 1: CODE OF CONDUCT AND DISCIPLINARY POLICY

This Code of Conduct (hereinafter, the "Code") is an integral and binding part of the Regulatory Framework and Rules of Participation (the "Rules"). Adherence to this Code is a mandatory condition for entry, participation, and continued Beneficiary status in the BSC AI Factory Incubation Space Programme. Any violation of this Code constitutes a material breach of the Rules and may result in disciplinary action up to and including immediate exclusion.

Article 15. Principles of professionalism and non-discrimination

- 15.1. The Programme operates a Zero-Tolerance Policy against all forms of discrimination, harassment, intimidation, bullying, or verbal or physical violence based on any protected characteristic (including but not limited to race, gender, religion, sexual orientation, disability, or nationality).
- 15.2. All Participants must strictly adhere to relevant national, European, and local anti-discrimination and anti-harassment legislation.
- 15.3. All interactions between Participants, Organizer personnel, and third parties must be conducted with the highest degree of professionalism, courtesy, and respect.

Article 16. Confidentiality and Intellectual Property Protection

- 15.1. Participants shall strictly observe and maintain the confidentiality of all proprietary information, trade secrets, project details, business plans, and any other non-public data (collectively, "Proprietary Information") belonging to the Organizer or other Participants.
- 15.2. The unauthorized disclosure, use, or exploitation of any third-party Proprietary Information encountered within the Incubation Space is strictly prohibited and constitutes a material breach of this Code and the Rules.

Article 17. Facilities use and Responsibility

- 17.1. All provided facilities, equipment, and resources must be used exclusively for the business purposes intended by the Programme. They must be utilized in a safe and responsible manner, respecting the shared nature of the spaces.
- 17.2. Participants are obligated to maintain the cleanliness, organization, and professional standards of their assigned workspaces, Hot Desks, and all shared common areas.
- 17.3. Participants shall be held financially and legally liable for any direct damage caused to the Organizer's facilities, equipment, or property due to negligence, wilful misconduct, or misuse.

Article 18. Health, Safety and Substance Policy

- 18.1. The consumption or presence of illegal drugs is strictly prohibited within the Incubation Space premises. The consumption of alcoholic beverages is generally prohibited, except for limited, pre-approved social events organized or sanctioned by the Organizer.

- 18.2. Participants are prohibited from entering the premises or engaging in Programme activities while under the influence of any substance that may impair judgment, safe conduct, or professional behaviour.
- 18.3. Participants must strictly adhere to all applicable health, fire, and safety regulations, as well as any specific safety protocols mandated by the Organizer or the building management.

Article 59. Communication, Public Disclosure, and Use of Identity

- 19.1. Participants shall not publish, disseminate, or otherwise make public, through any medium, including but not limited to social media, websites, press releases, marketing materials, public presentations, or events, any content that refers to, relates to, or is associated with the BSC AI Factory, the Incubation Programme, its facilities, activities, or community, without the prior written authorization of the Organizer.
- 19.2. This obligation applies to:
 - The use of the BSC AI Factory name, logo, trademarks, or visual identity
 - Any public reference to participation in the Incubation Programme
 - Photographs, videos, or recordings taken within the Incubation Space
 - Statements or materials that may imply endorsement, partnership, or institutional affiliation
- 19.3. Where authorization is granted, Participants shall ensure that all published content is accurate, non-misleading, and consistent with the information approved by the Organizer and with applicable communication and visibility requirements.
- 19.4. Any publication or dissemination of content in breach of this Article, including failure to obtain prior authorization or refusal to comply with a request for correction or removal, shall be considered a Moderate Breach (Tier 2) under the Disciplinary Policy set forth in this Annex, without prejudice to the Organizer's right to require the immediate withdrawal, correction, or amendment of the affected content.

Article 20. Disciplinary actions and Sanctions

- 20.1. The authority responsible for reviewing alleged breaches, conducting investigations, and determining the appropriate sanction is the BSC AI Factory Commission, advised by the Space Manager. The BSC AI Factory Commission's decision regarding the severity of the breach and the corresponding sanction shall be final and binding.

20.2. Violations of this Code shall be classified into three progressive tiers based on the nature, impact, and intent of the breach, each corresponding to a required range of sanctions:

Classification	Description & Criteria	Applicable Sanctions
Tier 1: Minor Breach	Accidental, Low Impact, or Negligible Offenses. Criteria include non-malicious intent, minimal disruption to operations, and first-time offenses (e.g., persistent messiness, minor noise violations, failure to adhere to administrative deadlines).	Verbal Warning (documented) or Formal Written Warning
Tier 2: Moderate Breach	Intentional, repeated, or medium-impact offenses. Criteria including repeated Tier 1 breaches after a formal warning, persistent or unjustified underuse of the Incubation Space, unauthorized guest access, or repeated violations of facility or booking rules.	Temporary Suspension of Privileges (e.g., loss of meeting room access for 30 days), Permanent Revocation of Specific Accounts and privileges or Exceptional exclusion from the Incubation Programme.
Tier 3: Severe Breach	High-Impact, Malicious, or Irreparable Offenses. Criteria include any violation Harassment/ Violence/Discrimination), unauthorized disclosure of Proprietary, significant damage to property, or any act that constitutes a criminal offense or jeopardizes the safety of the community.	Immediate Exclusion from the Programme, leading to the permanent loss of all remaining benefits without recourse.

20.3. The Procedure for the application of the sanctions will be the following:

- Upon notification of a potential breach, the Space Manager shall conduct an initial review. If the breach warrants further action, the case will be presented to the BSC AI Factory Commission.
- The accused Participant shall be notified in writing of the allegations and shall be afforded a minimum of three (3) business days to provide a written defense and/or clarification to the BSC AI Factory Commission before a decision is rendered.
- The BSC AI Factory Commission will evaluate the evidence, the Participant's defense, and the context (including any prior warnings on record) to assign the appropriate Tier classification and sanction.
- Disciplinary action taken by the BSC AI Factory Commission is without prejudice to any civil or criminal legal remedies available to the Organizer or any affected third party.

ANNEX 2: VALUE PROPOSITION & ECONOMIC VALUE

For transparency purposes, Participants are hereby informed that the actual economic cost incurred by the BSC AI Factory for providing one (1) desk space to a Participant at the relevant Incubation Site amounts to approximately four hundred and forty-two euros (€442) per month, for the full duration of the incubation period (six (6) months).

Accordingly, the total indicative economic value per Participant for the desk space over the entire incubation period amounts to two thousand six hundred and fifty-two euros (€2,652).

This indicative cost includes, inter alia:

- Access to one fully equipped desk space within shared hot desk areas
- Office supplies and shared infrastructure
- Internet connectivity and basic security services
- Access to shared meeting rooms, subject to availability and internal booking policies

This information is provided exclusively for transparency and informational purposes and **does not constitute a fee, invoice, payment obligation, or financial charge** for Participants.
